



CURRENT SITUATION OF THE OIL SPILL IN THE PASTAZA RIVER CONTROLLED BY PETROPERÚ

Lima, Peru, October 16, 2024 - Petróleos del Peru S.A. "Petroperú" or "the Company" (OTC:PETRPE) announced today that, the oil spill that occurred on October 03, 2024 at Km 11-12 of the North Branch Pipeline at the crossing of the Pastaza River, Andoas district, Datem del Marañón province, Loreto region, was controlled. This action is the result of the implementation of the first response works that consists of the closure of mechanical valves and the confinement of the hydrocarbon with the placement of containment barriers (see images in next page), which has made it possible to control the oil spill and prevent its expansion in the certified impacted together area, with specialized companies. These actions are part of Petroperú's Contingency Plan approved by the respective entities, which is activated immediately and has contemplated the movement of specialized teams by air and river. The work will continue with the cleaning of the area. Currently, there are no evidence of hydrocarbons at the place of the incident, which confirms that the situation is under control.

In parallel to these operational actions, the social team of Petroperú began coordination with the communal authorities of the area to make known the tasks deployed by Petroperú and the work can be carried out without inconveniences. It is also coordinating with the communal companies in the area to hire local labor in the initial cleaning tasks.

Petroperú will continue to report in a timely manner on the progress of the work and reiterates its commitment to act immediately in the face of these events, in close coordination with neighboring communities.
