

THE ACCESS TO THE INSTALLATIONS OF ONE OF THE PUMPING STATIONS OF THE NORPERUANO OIL PIPELINE WAS BLOCKED BY SURROUNDING COMMUNITIES

Lima, Peru, October 18, 2021 – Petróleos del Perú S.A. "Petroperú" (OTC:PETRPE) informed about an emergency situation occurred October, 4th, in the Norperuano Oil Pipeline (Oleoducto Norperuano - ONP), at the Pumping Station Number 5, at Manseriche, Province of Datem del Marañón, Loreto Region, as part of the call for the Amazon Strike promoted by both the Native Federation Awajún Río Apaga - FENARA and the Peoples Affected by Petroleum Activity - PAAP, who demanded the attention of the National Government for alleged breaches of its commitments.

The protesters entered through the main door of Station 5, claiming the arrival of the President of the Republic.

After several attempts at dialogue to avoid forceful actions, to the extent of its possibilities, Petroperú immediately activated its "Contingency Plan for cases of Social Commotion" in order to put its personnel in good safety and secure the facilities of the best possible way. Petroperú paralyzed its hydrocarbon pumping operations and proceeded with the evacuation of personnel from Stations 5 and 6, the corresponding police guard was coordinated, as the ONP is considered a Critical Asset National. This fact has been communicated to the Ministry of Interior, Ministry of Energy and Mines and OSINERGMIN.

Likewise, the corresponding legal actions are being taken, considering that the facts constitute a crime against public security in the modality of hindering the operation of public services, as well as coercion, house rape, among others.

The Company will keep the market informed as to any changes or updates regarding these situations.
