

ATTACKS AGAINST THE NORPERUANO OIL PIPELINE GENERATE MILLIONARY LOSSES TO PETROPERÚ

Lima, Peru, May 28, 2025 – **Petróleos del Peru S.A. "Petroperú" or "the Company" (OTC:PETRPE)** announced today that on March 19, 2025, a new attack was reported against the infrastructure of Norperuano Oil Pipeline (ONP), at Km 315+535 of Section II, located in the Sinchi Roca native community in the Loreto region. Petroperú immediately activated its Contingency Plan and managed to seal the drilling and contain the oil leak. However, the company's personnel were prevented from carrying out the work of collecting the hydrocarbon and cleaning the affected area. It should be noted that these actions promoted by the communal authorities and the leaders of their representative organizations against the ONP facilities are intended to pressure the Government to adopt decisions that guarantee the financing of local government investment projects.

Since the date of the attack, representatives of Petroperú with officials from the Presidency of the Council of Ministers and the Ombudsman's Office, have participated in various dialogue spaces with the Sinchi Roca native community and its representative organizations, with the aim of reaching agreements that will allow the cleanup activities to begin. This process leads to multiple adverse situations, such as the involuntary retention of workers and the obstruction of the operation of the insurance companies and containment systems.

During the last meeting held on May 21, 2025, representatives of the community expressed demands for the hiring of labor and the payment of daily wages that are unacceptable for Petroperú due to the distortions and perverse incentives that this would generate. They also threatened that, **if their demands were not met within 72 hours, they would proceed to remove the safety clip from the pipe and the containment systems installed.**

Unfortunately, **on May 27, 2025, a new attack against the ONP was reported, caused by the deliberate manipulation of the staple installed at the drilling point at Km 315 + 535**, which generated a new oil leak that reached a nearby stream, aggravating the impact on the ecosystem, and putting the public health of the surrounding population at risk.

To date, there have been **four attacks perpetrated against the ONP. Petroperú demands that the authorities, within the framework of their powers, urgently adopt the necessary measures to keep safe the integrity of this National Critical Asset**, whose operation demands an annual expenditure of more than US\$ 120 million from the company to ensure its operability and reliability. The continuity of these acts of vandalism not only compromises the operational sustainability of the ONP, but also represents serious damage to the environment and people's health.
